- **All Stakes** - single course without bird field or single course as an out and back without bird field. Wild & released quail and/or chukar and/or pheasants, on course.
- **Open Gun Dog and Amateur Gun Dog are retrieving stakes**
- **Open Gun Dog and Amateur Gun Dog will have 2<sup>nd</sup> series for retrieve**
- A blank cartridge will **NOT** be fired in the Puppy Stakes.
- **Horseback handling** will be permitted in all stakes except Amateur Walking Puppy and Amateur Walking Derby.
- **Tracking collars** will be allowed under AKC rules, not supplied by the club
- Handlers are responsible for getting their dogs to the starting line or dog wagon on time.
- Roading dogs behind the FT gallery is **NOT** allowed.

## PRIZES

Trophies to all 1<sup>st</sup> place dogs.  
AKC standard rosettes to all placed dogs.  
In addition to trophies and ribbons, the OLGD & GOLGD will have a cash payout.

\$25.00 of entry fee, in OLGD, will be split as follows:  
1<sup>st</sup> – 50%, 2<sup>nd</sup> – 25%, 3<sup>rd</sup> – 15%, 4<sup>th</sup> – 10%

40% of entry fee, in GOLGD, will be split as follows: 1<sup>st</sup> – 60%, 2<sup>nd</sup> – 40%.

If a placement is withheld, the money will be retained by the club.

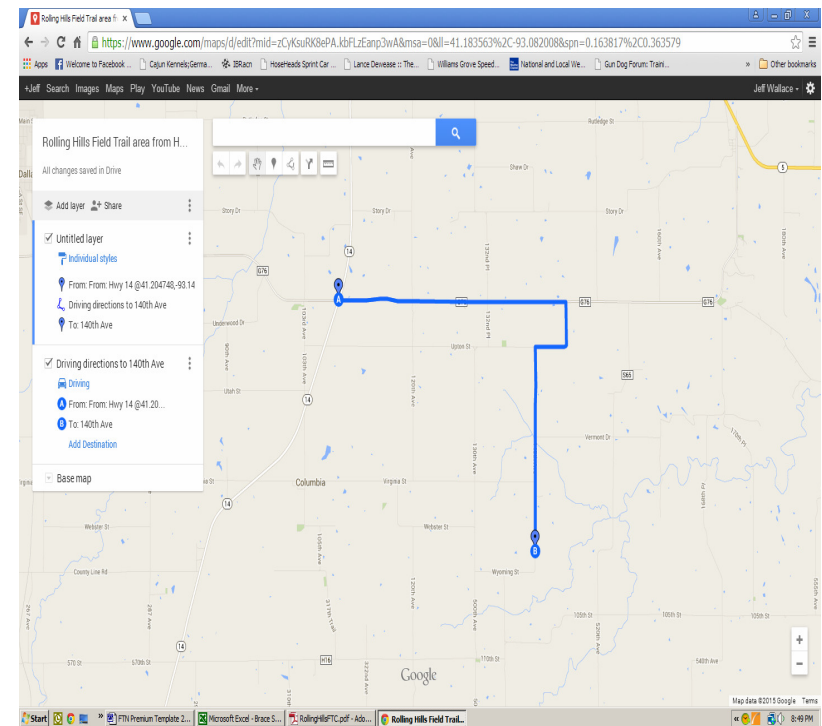
