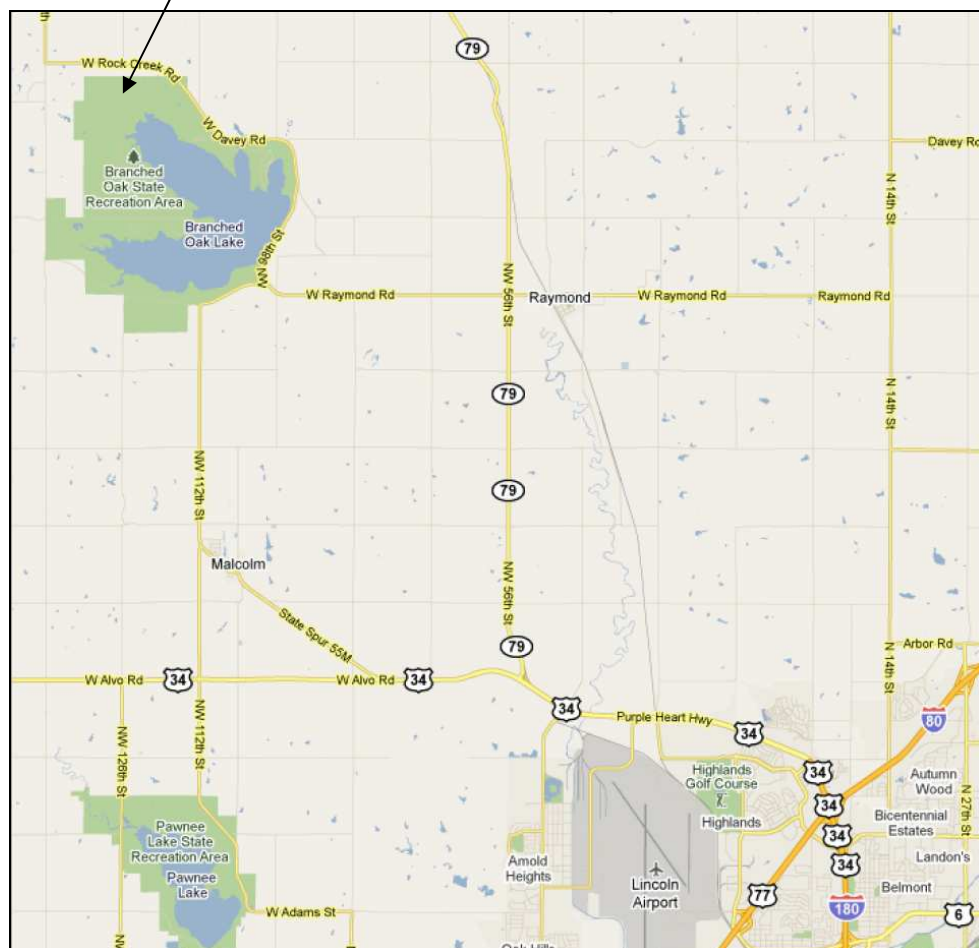

Open Puppy & Amateur Walking Puppy: Single course with no birds released.

Open All-Age, Amateur All-Age, Open Limited Gun Dog, & Amateur Limited Gun Dog: Are retrieving stakes.

Quail and/or chukar will be used in all stakes except Puppy. A blank cartridge will not be fired in the Puppy Stakes. Horseback Handling will be permitted in all stakes except Amateur Walking Puppy & Amateur Walking Derby. AKC Approved Tracking Collars permitted.
