
# Branched Oak Dog Trial Area, Raymond, NE

A blank cartridge will not be fired in the Puppy Stakes.

Horseback Handling will be permitted in all stakes except Amateur Walking Puppy & Amateur Walking Derby.

**Motels**: at Lincoln, NE, located within 15-20 minutes from the grounds Days Inn Airport – 2920 NW 12<sup>TH</sup>, 402-475-3616 Economy Lodge & Suites – 2410 NW 12<sup>th</sup>, 402-474-1311 Travelodge – 2801 West O St, 402-475-4921 Airport Inn – 3200 NW 12<sup>th</sup>, 402-475-9541 Holiday Inn Express Airport – 1010 W Bond , 402-474-1417

**Camping**: Overnight camping is allowed on the grounds. There is a \$3.00 charge for electrical hook-ups – payable to the Field Trial Chairman. Water is available on the ground for your animals. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds. **Please clean up after your animals in the camping area**.

**Food**: Breakfast and lunch will be served daily in the Field Trial Clubhouse.

**Training**: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.

**Horses**: Horses will not be available. For those of you bringing your own horses, pens are available on a first come, first served basis. There are also designated stakeout areas for horses.

**Entries**: Telephone entries are NOT accepted. All entries must be completed in full and fees MUST be paid to the Field Trial Secretary before the entry closing time.
