
Branched Oak Dog Trial Area, Raymond, NE

Camping: Overnight camping is allowed on the grounds. There is a \$3.00 charge for electrical hook-ups – payable to the Field Trial Chairman. Showers are located in nearby park facilities. Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.

Training: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.
