
# Branched Oak Dog Trial Area, Raymond, NE

Open Puppy & Amateur Walking Puppy: Single course with no birds released. Open All-Age, Open Gun Dog, & Amateur Gun Dog: Are retrieving stakes.

Quail and/or chukar will be used in all stakes except Puppy.

A blank cartridge will not be fired in the Puppy Stakes.

Horseback Handling will be permitted in all stakes except Amateur Walking Puppy & Amateur Walking Derby.

AKC Approved Tracking Collars permitted.
