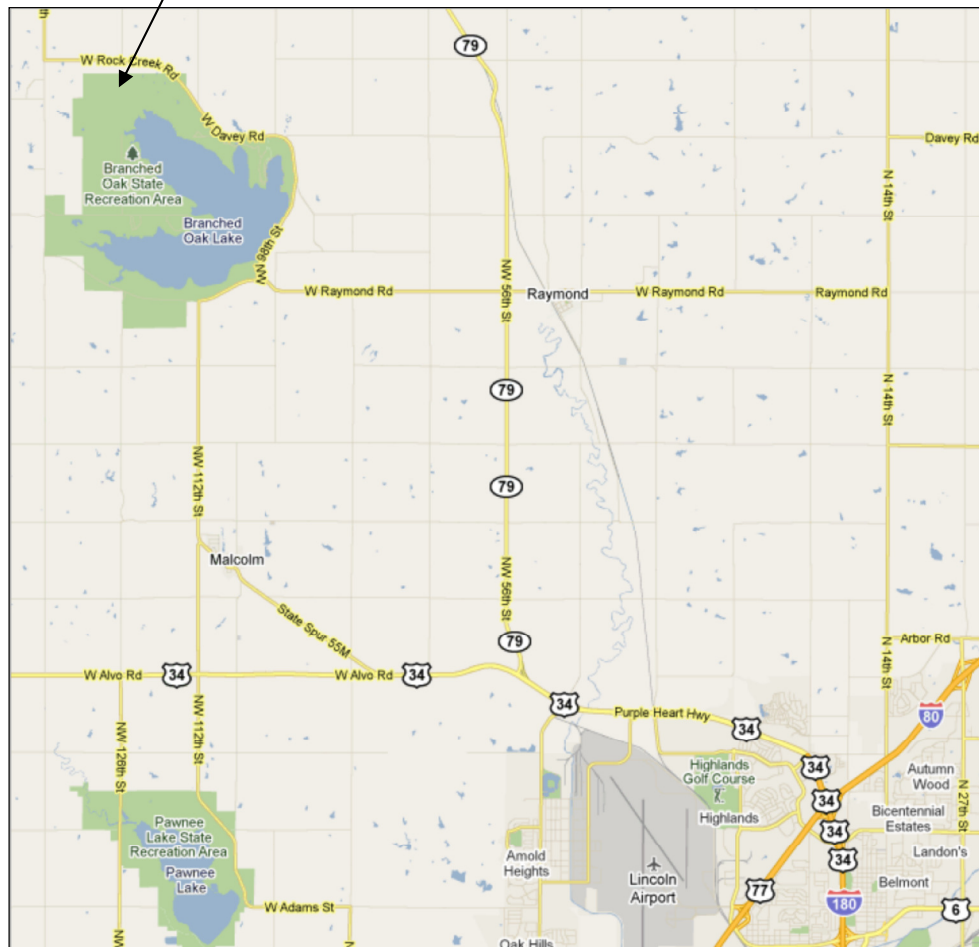

Horseback Handling will be permitted in all stakes.
AKC Approved Tracking Collars permitted.

Camping: Overnight camping is allowed on the grounds. There is a \$3.00 charge for electrical hook-ups – payable to the Field Trial Chairman. Water is available on the grounds for your animals. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds.
Please clean up after your animals in the camping area.

Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.

Training: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.

Horses: Horses will not be available. For those of you bringing your own horses, pens are available on a first come, first served basis. There are also designated stakeout areas for horses.
