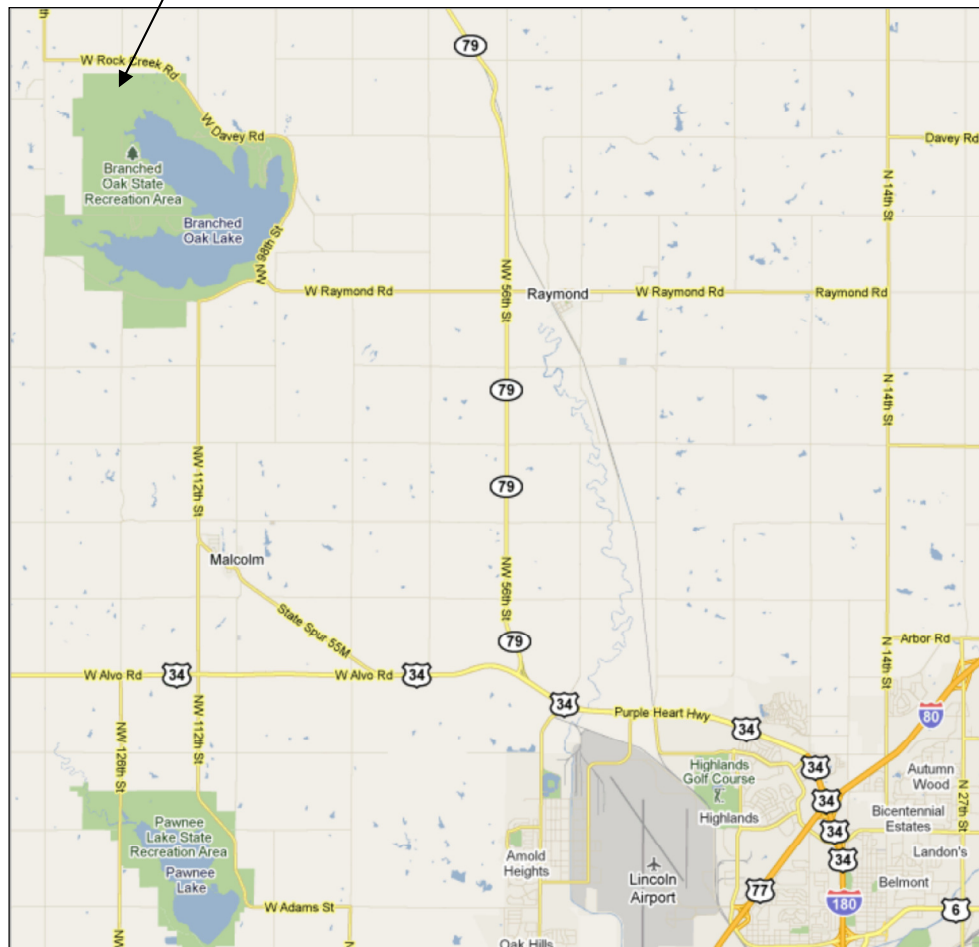

Horseback Handling will be permitted in all stakes.
