
Branched Oak Dog Trial Area, Raymond, NE

Camping: Overnight camping is allowed on the grounds. There is a \$7.00 charge for electrical camping locations – payable to the Field Trial Secretary. Water is available on the ground for your animals. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds. <u>Please clean up after your animals in the camping area</u>.

Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.
