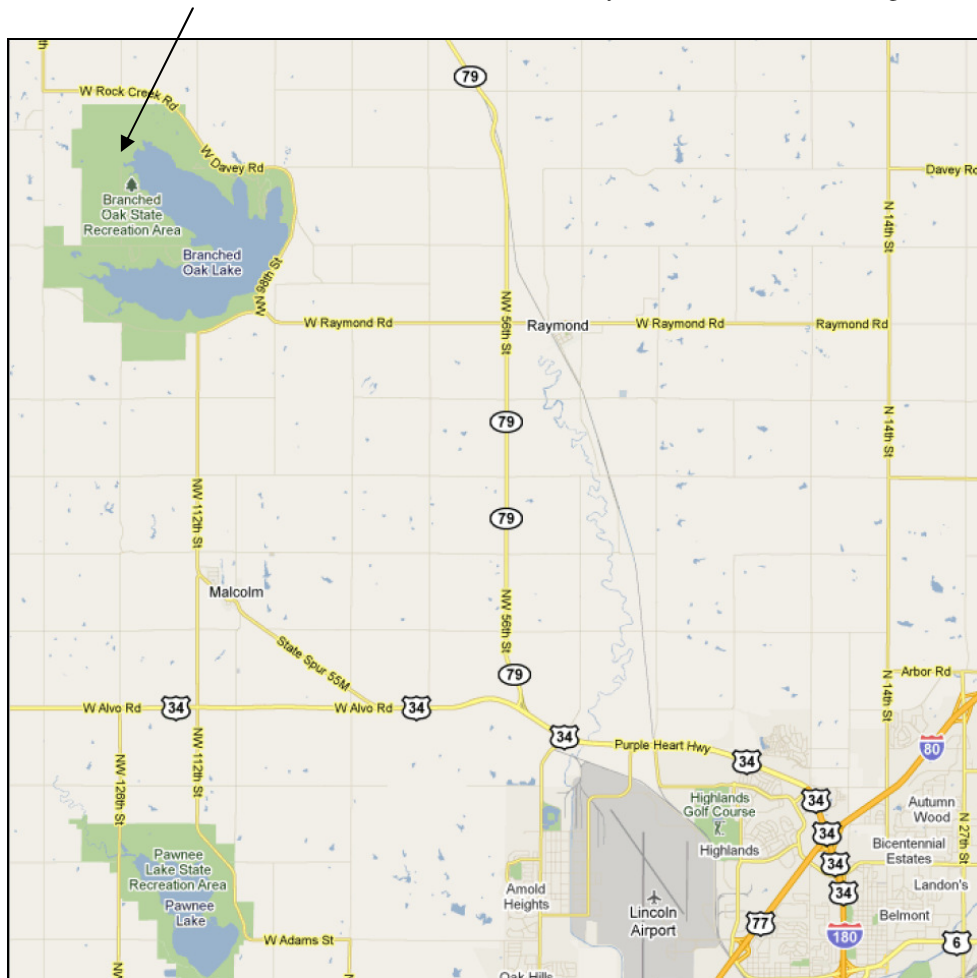


Branched Oak Dog Trial Area, Raymond, NE

Directions to the Trial Grounds: From Interstate 80, take Exit 401, Hwy W34, 4.5 miles Northwest of Lincoln. Turn right (north) on Hwy 79 & go 5 miles to West Raymond Road. Turn left (west) & go 3 miles. Take a right at the Branched Oak Sign & follow the blacktop around the lake for 5 miles. The field trial grounds are located at the Northwest corner of the lake. The entrance is on your left, marked with a sign.

Camping: Overnight camping is allowed on the grounds. There is a \$7.00 charge for electrical camping locations – payable to the Field Trial Secretary. State park stickers will be required to use park facilities outside of the field trial grounds. **Please clean up after your animals in the camping area.**
