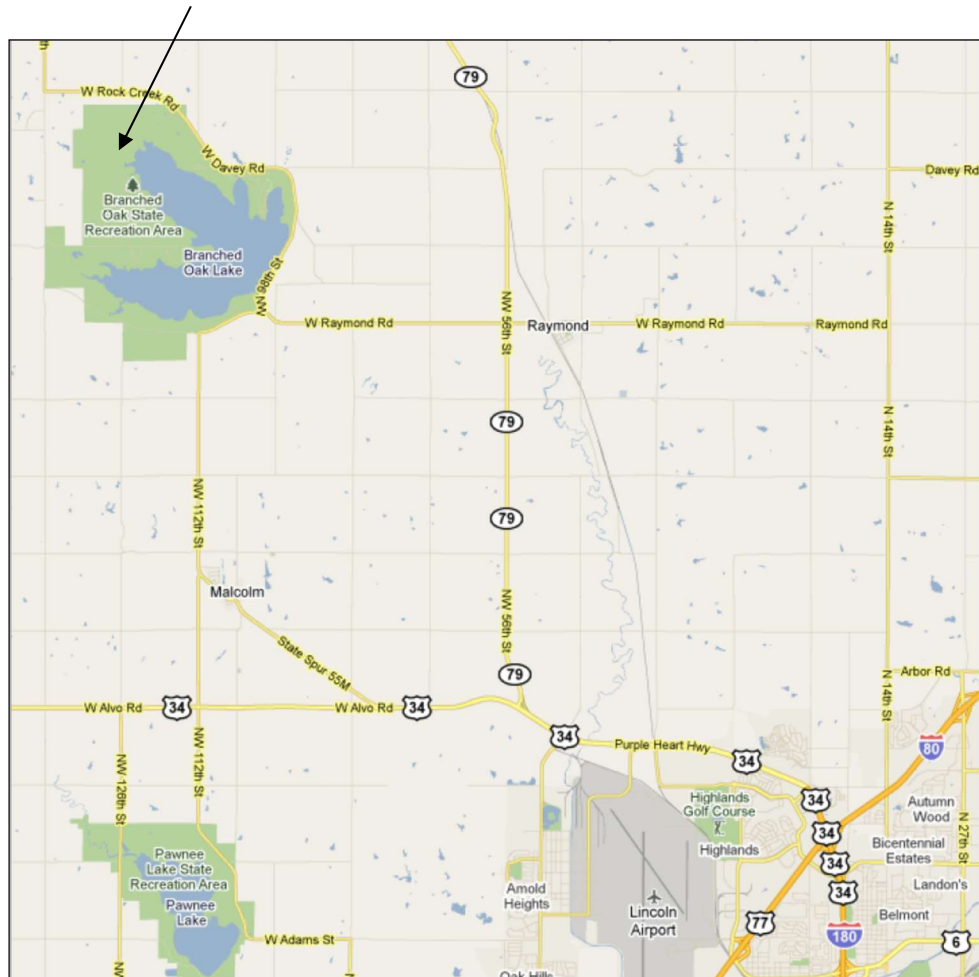

Camping: Overnight camping is allowed on the grounds. There is a \$7.00 charge for electrical camping spots – payable to the Field Trial Secretary. Water is available on the grounds for your animals. Please clean up after your animals in the camping area.

Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.

Training: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.
