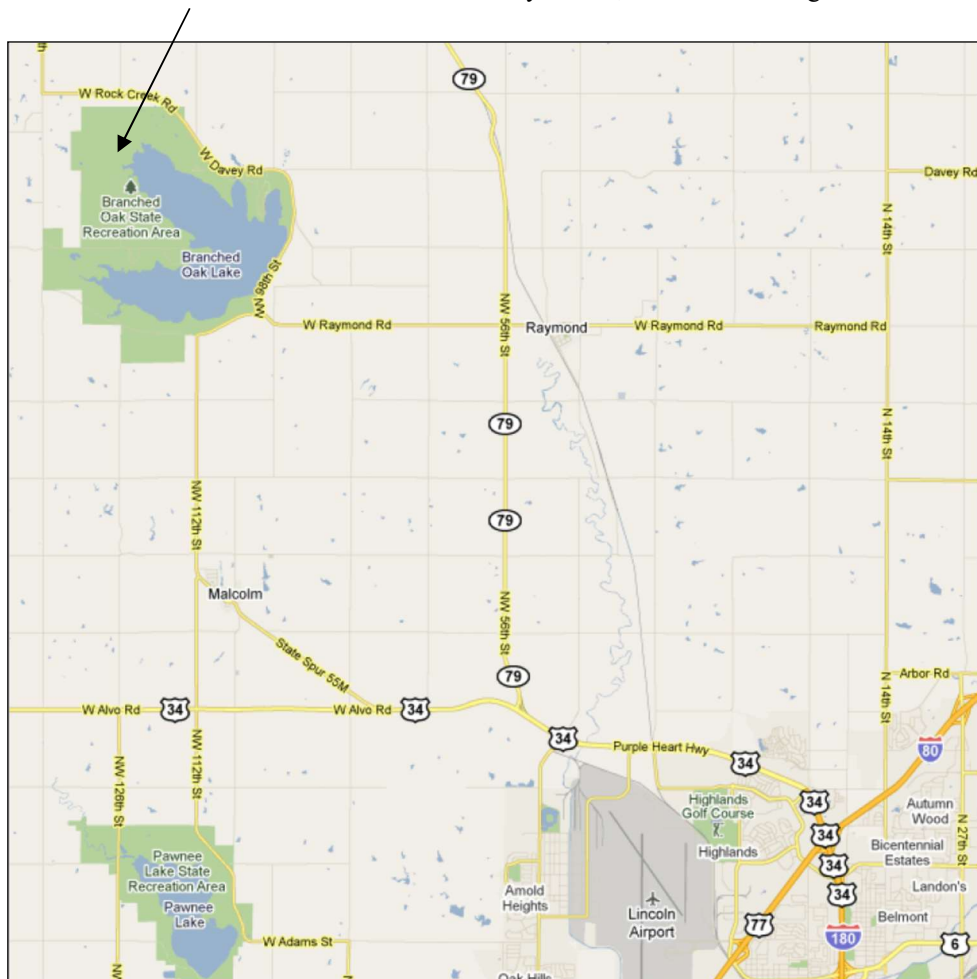

Open All-Age, Open Gun Dog & Amateur Gun Dog: Are retrieving stakes.

Quail and/or chukar will be used in all stakes except Puppy.

A blank cartridge will not be fired in the Puppy Stakes.

Horseback Handling will be permitted in all stakes except Amateur Walking Puppy & Amateur Walking Derby.

AKC Approved Tracking Collars permitted.

Roading dogs behind the FT gallery is not allowed

Camping: Overnight camping is allowed on the grounds. There is a \$7.00 charge for electrical hook-ups – payable to the Field Trial Secretary. Water is available on the ground for your animals. Please clean up after your animals in the camping area.

Food: Breakfast and lunch will be served daily in the Field Trial Clubhouse.
