
## Branched Oak Dog Trial Area, Raymond, NE

*Open Puppy & Amateur Walking Puppy:* Single course with no birds released. *Open Gun Dog & Amateur Gun Dog:* Are retrieving stakes. Quail and/or chukar will be released in all stakes except Puppy.

A blank cartridge will not be fired in the Puppy Stakes.

Horseback Handling will be permitted in all stakes except Amateur Walking Puppy & Amateur Walking Derby.

**Camping**: Overnight camping is allowed on the grounds. There is a \$7.00 charge for electrical camping locations – payable to the Field Trial Secretary. Water is available on the grounds for your animals. Showers are located in nearby park facilities. State park stickers will be required to use park facilities outside of the field trial grounds. **Please clean up after your animals in the camping area**.

**Food**: There are no caterers, watch for notification for lunch.

**Training**: Dog training is not permitted on the grounds. Training grounds for amateurs only are located southwest of Lincoln at Yankee Hill.
